

JACKSON COUNTY HORSESHOE CLUB 2023-24 WINTER LEAGUE BY-LAWS

1. THE GOVERNING BODY OF THE JCHC CONSISTS OF THE OFFICER STAFF AND TEAM CAPTAINS. THIS GROUP, COLLECTIVELY, IS REFERRED TO AS THE BOARD OF DIRECTORS.
2. THE OFFICER STAFF IS COMPRISED OF: PRESIDENT, VICE-PRESIDENT, SECRETARY, TREASURER, TOURNAMENT DIRECTOR AND MAINTENANCE/BUILDING ADVISOR (IF APPLICABLE)
3. THE OFFICER STAFF IS THE MANAGING BODY OF THE CLUB AND IS ELECTED ANNUALLY BY THE CLUB MEMBERSHIP AT THE SEASON END MEETING HELD IN CONJUNCTION WITH THE AWARD BANQUET.
4. THE TERM OF OFFICE FOR ELECTED OFFICERS IS FROM WINTER SEASON THROUGH SUMMER SEASON
5. TEAM CAPTAINS (ONE PER TEAM) ARE DESIGNATED BY THE TEAM MEMBERS OR SPONSOR IN WHATEVER MANNER THEY SEE FIT.
6. WITH THE EXCEPTION OF THE SEASON END MEETING WHERE IN ELECTION OF OFFICERS TAKES PLACE, ELIGIBILITY TO VOTE IS VESTED IN THE BOARD OF DIRECTORS. HOWEVER, ALL MEETINGS ARE OPEN AND COMMENTS AND SUGGESTIONS BY INDIVIDUAL MEMBERS ARE WELCOMED.
7. CHANGES TO THE ORGANIZATION AND BY-LAWS REQUIRE AGREEMENT, BY SIGNATURE OR VOTE, OF ATLEAST TWO-THIRDS OF THE MEMBERS OF THE BOARD OF DIRECTORS.
8. OFFICERS RESPONSIBILITIES:

PRESIDENT

- A. SCHEDULE ALL MEETINGS AND PRESIDES AS CHAIRMAN. PROGRAMS UPCOMING SEASONS ACTIVITY.
- B. ASSIGNS SPECIFIC PROJECTS AS REQUIRED.
- C. SERVES AS CHAIRMAN FOR THE SEASON END POT LUCK, INCLUDING PROCUREMENT OF AWARDS.
- D. MONITORS FINANCIAL MATTERS. COSIGNS WITH TREASURER ALL CHECKS IN EXCESS OF \$ 500.00.
- E. NOTIFY CAPTAINS WHEN PITCHING IS CANCELLED.

VICE-PRESIDENT

- A. ASSISTS, SUBSTITUTES FOR PRESIDENT AS NEEDED. RUN SEASON END CLUB TOURNAMENT.

VICE-PRESIDENT TO NHPA & MHPA

- A. RESPONSIBLE FOR LIASON BETWEEN JCHC, AND MHPA.
- B. MAINTAINS RECORDS OF BUSINESS BETWEEN JCHC, AND MHPA.
- C. KEEPS JCHC MEMBERS ADVISED, AND INFORMED CONCERNING WSHPA EVENTS AND ACTIVITIES.
- D. ASSITS, ADVICES OTHER JCHC OFFICERS AND MEMBERS AS NECESSARY.

SECRETARY/PUBLICITY

- A. FORMULATES, PUBLISHES AND DISTRIBUTES SCHEDULES FOR LEAGUE PITCHING.
- B. PROVIDES UP-TO-DATE HANDICAP CHARTS FOR REGULARLY SCHEDULED PITCHING.

- C. COLLECTS, EDITS SCORE SHEETS UPON COMPLETION OF REGULAR WEEKLY PLAY.
- D. PUBLISHES UP-TO-DATE STANDING REPORTS.
- E. PUBLISHES, DISTRIBUTES UP-TO-DATE COPIES OF THE JCHC ORGANIZATION AND BY-LAWS TO ALL OFFICERS AND CAPTAINS AS REQUIRED.
- F. NOTIFY TREASURER OF LEAGUE STANDINGS AND ALL AWARDS, ALSO FURNISH COPIES OF THESE ITEMS FOR ALL TEAMS.
- G. WORK WITH WEB MASTER UPDATING CLUB WEBSITE AS NEEDED.
- H. NOTIFIES LOCAL MEDIA, NEWS PAPER, TV, RADIO, OF ANY UPCOMING EVENTS AND RESULTS OF THOSE EVENTS.
- I. ESTABLISHES ACCOMADATIONS (SCRAPBOOKS ETC.) FOR PRESURVING CLUB PICTURES ETC. FOR HISTORICAL PURPOSES AND FUTURE ENJOYMENT.
- J. PREPARES AND SUBMITS MATERIAL FOR PUBLICATION IN THE NEWSPAPER.

TREASURER

- A. MAINTAIN AN ACCORATE RECORD OF ALL CLUB INCOME AND EXPENCES.
- B. HANDLE ALL JCHC CASH AND BANK ACCOUNTS.
- C. ISSUES CHECKS FOR JCHC FINANCIAL OBLIGATIONS WHEN THEY BECOME DUE.
- D. IS BONDED IN THE AMOUNT AGREED UPON BY JCHC OFFICERS.
- E. CARRIES OVER A MINIMUM OF \$ 200.00 TOWARD PRIZE FUNDS WITH WHICH TO BEGIN THE FOLLOWING SEASON.
- F. OBTAINS CO-SIGNATURES OF ANOTHER JCHC OFFICER ON ALL CHECKS IN EXCESS OF \$ 500.00.
- G. COLLECTS WEEKLY COURT FEES, YEARLY MEMBERSHIP DUES, AND SPONSOR FEES, ALL OF WHICH WILL BE FORWARDED FROM THE TEAM CAPTAINS.
- H. PREPARES AND PUBLISHES REPORT OF YEARLY MONEY TRANSACTIONS FOR INCLUSION IN SEASON AWARDS BANQUET PROGRAM.
- I. PROCURES CLUB'S LIABILITY INSURANCE COVERAGE.
- J. MAINTAINS UP-TO-DATE RECORD OF LIFETIME MEMBERS AND THEIR CONTRIBUTIONS.
- K. THE WINTER LEAGUE TREASURER WILL ASSIST IN THE ABOVE DUTIES. WILL MOSTLY ACT AS A MIDDLE MAN TO THE SUMMER LEAGUE TREASURER. THE WINTER LEAGUE TREASURER WILL FORWARD ALL MONEY TO THE SUMMER LEAGUE TREASURER ON A WEEKLY BASIS OR AS AGREED UPON.

TEAM CAPTAIN RESPONSIBILITIES

- A. ATTEND MEETINGS OF THE BOARD OF DIRECTORS.
- B. ARRANGE FOR TEAM MEMBERS TO REPRESENT HIS TEAM ON ALL PROJECTS WHERE COMPLETION IS DEPENDENT UPON CLUB MEMBER LABOR.

- C. PROMOTE TEAM IDENTIFICATION THROUGH SHIRTS, HATS, ETC. WITH TEAM SPONSORS NAME.
- D. RESPONSIBLE FOR CONDUCT AND SPORTSMANSHIP OF TEAM MEMBERS.
- E. RESPONSIBLE FOR "FIELDING" HIS TEAM AT THE SCHEDULED TIME AND PLACE.
- F. SUBMIT \$ 12.00 TO THE TREASURER EACH NIGHT BEFORE END OF GAME 1. (\$ 2.00 PER PERSON PER GAME) OFFICERS PAY WHEN PITCHING. PAYMENT TO BE REIMBURSED AT THE END OF THE SEASON.
- G. COLLECT WINTER CLUB MEMBERSHIP DUES (\$ 10.00 PER PERSON) AND TURN THIS OVER TO THE TREASURER PRIOR TO THE FIRST NIGHT OF PLAY. IF YOUR TEAM GAINS NEW MEMBERS THROUGHOUT THE YEAR, THESE NEW MEMBERS MUST ALSO PAY THE \$ 10.00 CLUB MEMBERSHIP DUE. LIFETIME MEMBERS DO NOT PAY THE WINTER \$10.00 MEMBERSHIP FEE.
- H. PROVIDE SECRETARY WITH TEAM ROSTER INCLUDING NAMES, AND ALSO THE TEAM CAPTAINS ADDRESS AND PHONE #.
- I. UPKEEP OF COURTS AND AREA PRIOR TO AND DURING PLAY. WATERING, TURNING, AND CLOSING OF COURTS AFTER PLAY IS COMPLETED. (ALL LEAGUE MEMBERS SHOULD TAKE PART IN THESE ITEMS)

CLUB RULES

- A. MEMBERSHIP ELIGIBILITY: ALL RESIDENTS OF MICHIGAN. FULL OR PART TIME.
- B. HALF WINNERS & THE FOUR TEAMS WITH GREATEST OVERALL POINT TOTALS ADVANCE TO THE SIX TEAM PLAYOFF PER SCHEDULE. TIES FOR A HALF DECIDED BY A 1 GAME PITCH OFF THAT SAME NIGHT. IN THE EVENT OF A TIE FOR THE FINAL PLAYOFF SPOT (OR DURING PLAYOFFS) A 1 GAME PITCH OFF WILL BE PLAYED THAT NIGHT. IF STILL TIED HALF GAMES WILL BE PLAYED UNTIL A WINNER IS DETERMINED (USING HALF HANDICAP ROUNDED DOWN) IF A TEAM WINS BOTH HALFS THEY SHALL RECEIVE TWO BYES INTO THE FINAL MATCH. THIS WILL MEAN ONLY THE TOP FOUR OVERALL POINT TOTALS WILL ADVANCE INTO THE PLAYOFFS. (#3 VS. #6) & (#4 VS. #5) WINNERS OPPOSE EACH OTHER, WITH THAT WINNER VS. #1A IF DUMMY TEAM IS REQUIRED ON EITHER LEAGUE NIGHT, THEY ARE NOT PART OF THE PLAYOFF EQUATION.
- C. THIS IS A 2 PERSON NON-WALKING DOUBLES LEAGUE. WE WILL PITCH 3 GAMES PER NIGHT AS SCHEDULED. EACH TEAM MAY HAVE UP TO 5 ROSTER PLAYERS. PLAY ON 1 ROSTER ONLY, NO SWITCHING ROSTERS MID-SEASON.
- D. ANY LEAGUE MEMBER 65 AND UP (CALENDAR YEAR) MAY MOVE UP AND PITCH 30 FEET. ANY LEAGUE MEMBER WITH A PHYSICAL DISABILITY MAY ALSO PITCH FROM 30 FEET. THE OFFICER STAFF WILL HANDLE ALL DISABILITY QUESTIONS. YOU MUST BE 65 YEARS OLD OR MORE (START CALENDAR YEAR) TO MOVE UP TO 30 FEET. IF YOU HAVE ALREADY MET THIS AGE REQUIREMENT AND WISH TO MOVE UP TO 30 FEET, YOU MUST DO SO FROM GAME #1 OF YOUR SEASON. IN EITHER CASE YOU WILL FOLLOW ALL RULES AS A NEW PLAYER WOULD, INCLUDING HANDICAP ESTABLISHMENT AND AWARD ELIGIBILITY. PLEASE NOTIFY YOUR TEAM, THE OPPOSING TEAM, AND THE SECRETARY WHEN MOVING UP TO 30 FEET. ONCE AGAIN, YOU MUST DO THIS FROM GAME #1 OF THE SEASON. NOT PART WAY THROUGH THE SEASON. THE NEWLY ADOPTED DISTANCE FOR MEMBERS 85 AND OVER (CALENDAR YEAR) WILL NOW APPLY BEGINNING 2022. STAND BEHIND THE 30 FOOT FOUL LINE AND TAKE ONE STEP OVER THE FOUL LINE. IF YOU HAVE ANY QUESTIONS OR CONCERNS NOTIFY YOUR LEAGUE SECRETARY.
- E. REGULAR TEAM PLAY HANDICAP FOR EACH PLAYER IS CALCULATED AS FOLLOWS:
SUBTRACT A PLAYERS AVERAGE FROM 88, THEN MULTIPLY THE DIFFERENCE BY 90%. A PLAYERS HANDICAP IS ALWAYS ROUNDED DOWN TO THE LOWER WHOLE NUMBER. NO PLAYERS HANDICAP IS TO BE GREATER THAN 72. A NEW PLAYERS

HANDICAP WILL BE ESTABLISHED AFTER PITCHING 2 GAMES (80 SHOES) BOTH GAMES TO BE PITCHED ON THE INITIAL NIGHT. THIS HANDICAP WILL THEN BE USED TO DETERMINE THE RESULTS OF THOSE GAMES PITCHED. THE HANDICAP FOR A NEW PLAYER WOULD THEN CHANGE WEEKLY, REGARDLESS HOW MANY GAMES HAVE BEEN PITCHED. THE NEW PLAYER RULE ALSO APPLY TO PLAYERS MOVING UP IN DISTANCE, AND PLAYERS WITH LESS THAN 12 GAMES PITCHED IN THE PREVIOUS WINTER LEAGUE. SUMMER LEAGUE PLAYERS (12 GAMES) SAME YEAR THAT DIDN'T PLAY PREVIOUS WINTER LEAGUE WILL ALSO BE ALLOWED TO USE THAT HANDICAP, JUST AS RETURNING WINTER LEAGUE PLAYERS (12 GAMES) DO. THESE PLAYERS HDC. WILL THEN ADJUST AFTER 6 GAMES HAVE BEEN PLAYED. THESE PLAYERS WILL BE ELIGIBLE FOR ALL AWARDS FROM DAY 1. MINIMUM # OF GAMES PITCHED FOR PARTICIPATION ELIGIBILITY ARE AS FOLLOWS:

1ST HALF POSITION ROUND (6 GAMES) 2ND HALF POSITION ROUND AND PLAYOFFS (12 GAMES)

F. NO PERSONS GAMES PITCHED, OR HANDICAP WILL CARRY OVER FROM THE SUMMER TO THE WINTER LEAGUES. WHEN MULTIPLE 40 SHOE LEAGUES EXIST YOU WILL BE ALLOWED TO USE YOUR ENDING HANDICAP AS A STARTING POINT IN OTHER LEAGUES. (12 GAMES OR MORE PITCHED) THIS RULE DOES NOT APPLY WHEN YOU HAVE PITCHED 12 OR MORE GAMES AND ESTABLISHED A HANDICAP FROM THAT SAME LEAGUE (WINTER/SUMMER) THE PREVIOUS SEASON. IN THIS CASE THAT HANDICAP WILL ALWAYS TAKE 1ST PRIORITY BECAUSE PITCHING CONDITIONS ARE SAME. ONCE YOU ESTABLISHED YOUR ROSTER LEAGUE HANDICAP (6GMS) YOU WILL USE THIS HANDICAP WHEN SUBBING AS A NON-ROSTER SUB. ROSTER SUBS WILL USE THE HANDICAP PROVIDED IN THE LEAGUE NIGHT THEY ARE SUBBING WITHIN.

G. IN REGULAR TEAM PLAY, A GAME CONSIST OF TWO PLAYERS ON EACH TEAM OPPOSING ONE AND OTHER. EACH PLAYER PITCHING 40 SHOES. TEAMS ALTERNATE FIRST PITCH EACH FRAME TO 20 FRAMES (2 SHOES PER FRAME) THE COUNT ALL METHOD OF SCORING IS USED. RINGER 3 POINTS, SHOES 6 INCHES OR CLOSER TO THE STAKE 1 POINT.

ANY SHOE NOT FIRST LANDING IN THE CLAY AREA OR TOUCHING A MAN-MADE STRUCTURE PRIOR TO LANDING IS CONSIDERED A DEAD SHOE, AND DOES NOT COUNT. THIS DEAD SHOES MOVEMENT OF OTHER SHOES DOES STAND. ONCE THE DEAD SHOE HAS STOPED , IT IS REMOVED FROM PLAY AND PLAY CONTINUES ON AS NORMAL.

H. A TEAM MAY PARTICIPATE IN A LEAGUE GAME WITH A MINIMUM OF ONE ROSTER PLAYER, AND A BLIND SCORE OF 80 (ABSENT PLAYER) OR A SUB. YOU ARE ALLOWED TO BE ON 1 ROSTER PER LEAGUE NIGHT. 5 PERSONS MAX PER TEAM. SUBS ARE ALLOWED. YOU MAY NOT SUB AGAINST YOUR OWN TEAM. IF YOU WISH TO BE A ROSTER MEMBER ON MULTIPLE NIGHTS YOU HAVE TO PAY THE \$10.00 CLUB MEMBERSHIP DUES FOR EACH NIGHT. PLAYERS MAY SUB ON OFF NIGHTS AT NO COST AS LONG AS THEY ARE A ROSTER MEMBER OF TUESDAY OR THURSDAY. (NON-ROSTER SUB) NO SUBS ARE ALLOWED ON POSITION AND PLAYOFF NIGHTS. *THE ONLY EXCEPTION TO THIS RULE IS A MEDICAL EMERGENCY APPROVED BY THE LEAGUE OFFICERS. IF 50% OR MORE OF THE LEAGUE OFFICERS APPROVE, A SUB WITH QUALIFYING MINIMUM # OF GAMES PLAYED CAN PITCH. THIS SUB'S HANDICAP MUST BE EQUAL OR GREATER TO WHOM THEY REPLACE. TEAMS PLAYING WITH AN ABSENT PLAYER WILL RETRIEVE THE HORSESHOES OR WITH OPPOSINGS TEAM APPROVAL, MAY ALLOW A PERSON TO THROW THE SHOES BACK. UNDERSTANDING THE SCORE PITCHED DOES NOT COUNT, BUT THE

DAMAGE THE SHOES MAY CAUSE WILL COUNT. OPPOSING TEAM MUST AGREE TO SHOES BEING THROWN BACK.

I. A 10 POINT SCORING SYSTEM WILL BE USED FOR TEAM PLAY: 1 POINT AWARDED FOR INDIVIDUAL GAME WON, 1 POINTS AWARDED FOR HIGH TEAM TOTAL EACH GAME, AND 1 POINT FOR OVERALL GRAND TOTAL. MEANING 3 POINTS AVAILABLE PER GAME, AND 1 AVAILABLE FOR GRAND TOTAL.

WHEN TWO PLAYERS TIE EACH IS AWARDED 1/2 POINT. IF YOU TIE FOR TEAM GAME TOTAL THE 1 POINT WILL BE SPLIT, EACH TEAM GETTING 1/2 POINT. A TIE FOR OVERALL GRAND TOTAL IS ALSO SPLIT, 1/2 POINTS EACH.

J. LEAGUE PLAY STARTS AT 6:00. IF A TEAM CANNOT PLACE THE PLAYER MINIMUM ON THE COURTS BY 6:15, THAT TEAM FORFEITS THE FIRST GAME. IF BY 6:30 THAT TEAM IS STILL UNABLE TO BEGIN, THE ENTIRE THREE GAMES ARE FORFEITED. (0 PTS.) THE TEAM OPPOSING THE FORFEIT MUST PITCH ALL THREE GAMES, COMPETING AGAINST YOUR OWN INDIVIDUAL AVERAGE. PITCH ALL GAMES ON ONE COURT, FOLLOW THIS SAME RULES WHEN OPPOSING A DUMMY TEAM. BOTH TEAMS ARE STILL REQUIRED TO PAY THE \$12.00 WEEKLY PITCHING FEES. TEAMS FORFEITING MORE THAN 9 GAMES SHALL BE INELIGIBLE FOR PLACING IN THE TOP 5 WINNING POSITIONS. INDIVIDUAL OPPONENT MATCHUPS BY CAPTAINS CAN BE ALTERNATED EACH GAME. THE "AWAY TEAM" (TEAM ON RIGHT SIDE OF SCORESHEET) WILL PLACE PLAYERS NAMES ON THE CHALK BOARD FIRST IN GAMES 1 AND 3. THE "HOME TEAM" (TEAM ON THE LEFT SIDE OF SCORE SHEET) WILL PLACE NAMES ON THE CHALK BOARD FIRST IN GAME 2. IN EITHER CASE THE OTHER TEAM WOULD THEN MATCH UP PLAYERS AS DESIRED. MATCHUPS ARE FINAL ONCE THE 1ST SHOE IS PITCHED. EACH TEAM WILL HAVE 7 HOME AND AWAY SCHEDULED MATCHES. DURING POSITION ROUNDS THE HOME TEAM WILL BE THE TEAM WITH THE MOST POINTS. (IF TIE, PREVIOUS WEEK HIGHER PLACE IN STANDINGS) DURING THE PLAYOFFS THE HOME TEAM WILL BE THE TEAM WITH THE MOST OVERALL POINTS, EXCEPT WHEN OPPOSING A HALF WINNER. HALF WINNERS WILL ALWAYS BE THE HOME TEAM. IF HALF WINNERS OPPOSE EACH OTHER THE HALF WINNER WITH THE MOST OVERALL POINTS WILL BE HOME.

K. A NEW PLAYERS ELIGIBILITY FOR INDIVIDUAL HIGH HDC. GAME OR SERIES BEGINS AFTER 6 GMS. (240) SHOES. PLAYERS WITH 12 GAMES FROM PREVIOUS SUMMER OR WINTER LEAGUE ARE ELIGIBLE FROM GAME 1 OF WINTER.

L. A MINIMUM AGE FOR LEAGUE MEMBERSHIP WILL BE 16. THOSE UNDER 18 OR STILL IN HIGH SCHOOL WILL HAVE WRITTEN PERMISSION FROM THEIR PARENTS OR LEGAL GUARDIAN.

M. THE PRESIDENT & VICE-PRESIDENT WILL MAKE THE FINAL DECISION ON CANCELLATION OF LEAGUE PLAY. IF THE DECISION TO CANCEL IS MADE THE PRESIDENT OR VICE PRESIDENT WILL NOTIFY THE TEAM CAPTAINS AT THE PHONE # GIVEN TO US PRIOR TO 5:00 P.M. EVENING OF PITCHING. NO ONE WILL BE ALLOWED TO PITCH ON THIS CANCELLED NIGHT. ALL MAKE UP PITCHING DECISIONS WILL BE UP TO LEAGUE OFFICERS. IF THE PITCHING IS NOT MADE UP POINTS FOR THOSE NIGHTS WILL BE SPLIT EVENLY, AND EACH TEAM IS STILL RESPONSIBLE FOR PAYING THE WEEKLY COURT FEES.

N. IF FOR ANY REASON A PLAYER CANNOT FINISH HIS OR HER GAME, THEY WILL USE THE LOWER OF THE NEXT TWO OPTIONS: A FLAT SCORE OF 80, OR CALCULATE THE PLAYERS AVERAGE PER FRAME UP TO THE POINT AT WHICH THEY STOPPED, AND EXTEND THAT OUT TO 40 SHOES.

O. NO SMOKING OF ANY KIND WILL BE ALLOWED INSIDE THE HORSESHOE PITCHING BARN.

A. ALL INDIVIDUAL AWARDS REQUIRE 1/2 OR MORE GAMES PITCHED. NEW PLAYERS OR PLAYERS MOVING UP TO 30 FEET ARE NOT ELIGIBLE FOR INDIVIDUAL HIGH GAME & SERIES UNTIL 6 GAMES HAVE BEEN PITCHED, NOR IS THEIR TEAM ELIGIBLE FOR TEAM AWARDS UNTIL 6 GAMES HAVE BEEN PLAYED.(BASED ON PARTISIPATION OF NEW PLAYER) IF A SUB IS USED YOUR TEAM IS NOT ELIGIBLE FOR FOR HIGH TEAM GAME FOR THAT GAME.
